





## 數位身分證上個資三區塊

The Three Data Blocks on the Digital ID Card

1. 政府規定資訊 Government Mandates Necessary Information Disclosure #必要個資 #更改須審核 #讀取輸入讀取碼

政府規定資訊更改須經政府機關審核,輸入身分證統號後六碼(讀取碼)即可檢視讀取: 包含中文姓名、外文姓名(由民眾選擇)、出生日期、統一編號、婚姻狀態(有/無)、 製證日期及應換領日期。

The government mandates the placement of essential personal information, requires input of a reading code, and changes must undergo approval. This includes details such as name, date of birth, and ID number.

## 2. 自訂揭露資訊 Citizens' Freedom to Choose Information Disclosure #民眾選擇揭露 #隱私自訂 #溯源機制 #更改冷卻期

給予民眾選擇更改資訊的權利,以呈現最貼近真實狀況的自我,並且可以根據個別資訊 選擇分享對象(例如:朋友、公開或只限本人):包含家庭、寵物、教育程度、職業、 星座、MBTI人格、生理性別(可以性別認同取代)、**性別認同光譜**等...

Individuals can freely disclose and update this information to reflect their most authentic selves in real-time. Information privacy is customizable, and there is a traceability mechanism and a change cooling-off period for any data modifications. This includes educational level, personality traits, biological gender (replaceable with gender identity), and the gender identity spectrum.





# 3. 隱私加密資訊 Personal Confidential Information #自訂憑證密碼 #個人同意/政府授權才有讀取權

需要自訂憑證密碼,服務提供者(金融、法院及醫院等公務)須向政府機關申請授權, 始得讀取加密區資料,部分資訊得以於指定情境讓指定人士取得:包含病歷、器捐意願、 隱疾、生物特徵、聯絡方式、財務情況、遺囑、指定代理人等...

Custom certificate passwords are required, and service providers (such as financial institutions, courts, and hospitals) must apply to the government for authorization to access encrypted data. Some information may be made accessible to designated individuals in specified contexts. This includes medical records, organ donation preferences, biometric data, financial status, wills, and designated proxies.






If the spectrum axis still doesn't align with people's expectations for their identity, they can use text, symbols, or other colors through customizable options to represent the state that best reflects their personal identification.

# 導入性別認同光譜數位身分證應用場景

After the implementation of gender identity spectrum, the digital ID card can be applied in the following scenarios:

#### 商業應用 Business

Through the integration of technology, businesses can utilize the personal information provided by individuals to streamline information flows, enabling precise marketing and services. Online users can also simplify complex identity verification processes, speeding up online activities, whether it's for social welfare, civic voting, or business transactions, thus realizing digitization and expediting these processes.



透過科技導入,民眾只要攜帶綁定數位身份證之裝置,並開啟感測技術進入店家場域,經設定允許提供資訊的情況下,店家能夠感應裝置存取個人資訊。根據民眾提供資訊,串聯人流、金流相關數據,整合消費者行為分析,提供精準行銷,並給予更細膩的商業服務,持續優化民眾體驗。



利用科技媒介得即時更新符合現狀的個人狀態,簡化數位身份網路驗證步驟,取而代之的是社會福利、公民投票甚至商業活動等得以落實數位化,只需輸入識別碼或掃描生物特徵,即可快速完成登入、進行交易。申辦任何社群平台都可以應用,快速填入更新個人資訊,大幅簡化繁雜程序。

# 導入性別認同光譜數位身分證應用場景

After the implementation of gender identity spectrum, the digital ID card can be applied in the following scenarios:

### 公私部門 Public and Private Sectors

Government and corporate organizations can take the lead in establishing a diverse-friendly workplace culture and providing the necessary support and assistance to diverse individuals. Additionally, gender-friendly guidelines can be formulated to ensure neutrality when exercising public authority and providing services, avoiding questioning of gender preferences. It's important to respect individual self-awareness and prevent recurring situations that make people uncomfortable and awkward.



政府與公司應帶頭建立多元友善的文化,對於不願透露性別認同的員工給予尊重,而對於自信展現自我的員工給於支持,根據其性別認同提供心理健康支援、性別轉變相關服務,以及鼓勵性別多樣性社群發展,使個人更容易獲得符合其性別認同的支持協助。



#### 建立性別友善規範指引

在行使公權力執法盤查時 , 能避免質疑與偏見 , 若有搜身必要以性別認同欄位作為參考跟據 , 須尊重個人意願安排合適人員進行 , 保障其人格尊嚴 。 公私部門稱呼民眾時皆應避免預設立場與質疑性別傾向 , 並以性別認同欄位作為稱呼依據 , 避免發生尷尬或造成心理不適的場面 。
